- To comply with legal obligations.

Anonymized and aggregated data may also be used for research, statistical analysis, and business planning.

Disclosure of Personal Information:

We may disclose your personal information:

- To affiliates, service providers, and business partners involved in delivering the Pilot.
- For marketing purposes to third parties, unless you opt-out. Unless prohibited by local law, you are automatically opted-in to such sharing, but you may withdraw your consent at any time by opting-out.
- To other third parties as required by local regulations or to comply with legal processes, without additional consent.
- To protect our rights or safety, and the rights or safety of others.
